We encourage those with the first, second, and third printings of the first edition to write these corrections directly into the Manual.

- **Introduction Part B, page 5:** Correction of spelling error in (6) (discusses to discusses).
- **Rule 7:** All entries to the Wolfram book should be to § 9.4.5 (some of the numbers were reversed in the first printing).
- **Rule 12.4(a)(2):** In the list, a preference has been added for regional reporters when a state case is cited.

A West reporter (regional reporters for state cases);

- **Rule 12.7(c):** Docket numbers were removed to conform to Rules 12.12 and 38.

- **Rule 13 (Constitutions), Fast Formats:** Change entry for “Full citation for state constitutions (provisions not currently in force)” to:

Cal. Const. art. XVII (repealed 1949 by Cal. Const. art. XXI).

- **Rule 15.9, example on page 124 of a Senate Document:** Change date to Apr. 30, 1999 (since April does not have 31 days).

- **Rule 17.1, page 151, example for ABA Model Rules of Professional Conduct:** Change number to correct format; entry should read:

ABA Model R. Prof. Conduct 1.2 (1998).

- **Rule 22.1(3)(a), page 187:** Appendix 5 may also be used to abbreviate words in an organization’s name.

To save space, you may abbreviate any words in the organization name that appear in **Appendix 3** or **Appendix 5**

- **Rule 22.1(i):** Correct Cowans example to add comma after the edition:

Corrected entry:

Daniel R. Cowans, *Bankruptcy Law and Practice* vol. 2, § 4.4 (7th ed., LEXIS L. Publg. 1998).

- **Rule 39.1(c):** Spelling of “identifier” corrected in the last line of the first paragraph.
- **Rule 43:** The correct title of the AALL is the American Association of Law Libraries. This organization’s name will be corrected in **Rule 43.1** and **Rule 43.2(b)**.
- **Rule 48.4(c), Example:** Correct wrong word in second line of quotation:

The court concluded . . . “improperly directed the witness

(“with” changed to “the”)

- **Rule 48.7(b), correct pinpoint in *Miranda* citation from 441 to 447-448.**
- **Rule 48.7(c)(1): Delete the second “not” in the third line of the entry.**
- **Rule 50.3(b), item 3: “At” should be capitalized:**
 - (3) At the end of a block quotation

● **Appendix 1, California entry:**

- For Deering’s Civil Code Annotated of the State of California, change the publisher in the format section from Bancroft-Whitney to LEXIS L. Publg.

- Under “**Session law**,” correct “Statues” to “Statutes”

● **Appendix 1, Connecticut entry, “Local citation rules”:**

Connecticut does have local citation rules, which are included under “Updates” on the www.alwd.org Web site.

● **Appendix 1, Illinois entry, “Statutory compilations”:**

For both listed codes, delete the section *symbol* from the format.

● **Appendix 1, Maryland entry, “Statutory compilations”:**

Add:

Annotated Code of Maryland (1957)

Md. Ann. Code art. **article number**, §
section number (Year).

● **Appendix 1, Pennsylvania entry, “Statutory compilations”:**

Add:

Purdon’s Pennsylvania Statutes Annotated

Pa. Stat. Ann. tit. **title number**,
§ **section number** (West Year).

● **Appendix 1, Texas entry, Courts:**

On page 371, this entry should be for the Texas Court of Appeals (Tex. App.), not the Texas Court of Criminal Appeals, which is the prior entry.

● **Appendix 1, Texas entry, “Statutory compilations”:**

The correct name for the second entry is:

Vernon’s Texas Revised Statutes Annotated

● **Appendix 1, page 377 (federal statutory compilations):**

The abbreviations for United States Code Annotated and United States Code Service are listed incorrectly. The correct abbreviations are:

United States Code Annotated

U.S.C.A.

United States Code Service

U.S.C.S.

● **Appendix 2, Connecticut:** Note that there is an entry in “Updates” on the Web for **Connecticut**. We cannot incorporate this change until the second edition, which is scheduled for 2003.

● **Appendix 2, Michigan entry:**

● In the third line, “Article” should be *Manual*.

● Note that local rules also require parallel citations to Michigan cases.

- **Appendix 4, Sidebar A4-1:** The Appendix reference should be to Appendix 3(B)

- **Correct abbreviation for Texas Journal of Women and the Law to**

Tex.^J.^Women^&^L.

(note: ^ = space)

(final period was omitted in the first three printings)

- **Correct abbreviation for Tulsa Journal of Comparative & International Law to**

Tulsa^J.^Comp.^&^Intl.^L.

(note: ^ = space)

(initial word was inadvertently abbreviated Tul., which is the designated abbreviation for Tulane)

- **(Web version): Add the new journal:**

North Carolina Journal of Law & Technology

N.C.^J.L.^&^Tech.

(note: ^ = space)

- **Index:**

- **Entry for “ALWD Citation Manual”:** Change page 4 to page 8 “citation for” and “Web site for.”

- **Entry for “American Association of law Librarians”** should be “American Association of Law Libraries.”

- **Entry for “Internet,” then subentry for “case citation format”:** Change 12.13 to 12.15.
