## QUESTION #1

**For the following case, please supply the correct citation that you would use in a memorandum:**

The case of James Tiberius Kirk versus Jean-Luc Picard appears in the second series of the Atlantic Reporter, at volume 145, on page 290. It was decided in 1990 by the Pennsylvania Supreme Court, and was printed in their official reporter in volume 299, at page 211.

**Then supply a citation to the same case that would appear two sentences later, after a quotation from page 299 of that opinion, where no other citations intervene.**

## QUESTION #2

Please provide a short form citation for the case cited in #1, using just the regional reporter, citing to page 292. Assume there are several intervening citations to other authorities.

## QUESTION #3

Please revise these textual sentences and/or citations:

Gambling is prohibited by statute in the state of Arkansas. Section 4-21-98 of the Arkansas Code (1988). Sect. 4-21-98 prohibits all forms of gambling. (You should also see the following 1885 case that explains that statute -- STATE OF ARKANSAS V. GAMBLING OUTPOST #4, which appears in volume 101 of the Arkansas Supreme Court Reporter. That case begins on page 445, and the relevant text is found on pages 446 through 447).

## QUESTION #4

Please revise the text and/or citations as it would appear in a memorandum:

The court adopted an accountant-client privilege which had not been recognized by the Trial Court. Tyson v. Perdue, 767 N. W. 2d 312 (Wis. 1981). The Court reversed and remanded the case for a new trial in which all the accountant's testimony was to be excluded. *ibid.*, 313.
