

## Who Votes at Law School Faculty Meetings in the United States?

Some of the information on legal writing faculty status was taken from Susan P. Liemer and Jan M. Levine, *Legal Research and Writing: What School Are Doing, and Who is Doing the Teaching (Three Years Later)*, 9 Scribes J. Leg. Writing 113 (2003-2004), and some of the information on voting opportunities for clinicians and legal writing professors was taken from responses to the 2005 ALWD-LWI Survey, for which aggregate statistics are available at <http://www.alwd.org>.

For easier visualization of an overall picture, shading of a square indicates broad voting opportunities are granted. Unless otherwise noted, when “vote on all matters” refers to tenure-track faculty, the underlying assumption is that they “vote on all matters *except P&T until tenured*.” Also, unless otherwise noted, visitors and adjuncts do not vote. Any students who teach presumably do not vote. And finally, “library” refers to the law school library, unless the university library is specifically indicated. For the sake of brevity within the chart, I decided not to repeat these generally-understood norms in the many instances in which they apply.
