General Background:

After 10 years as a law librarian where I researched and wrote about leadership and changes in academic libraries, as well as research technology and access to justice, I was delighted to move over to Stetson's full-time faculty where I teach LRW and Technology courses. My scholarship centers around the ways legal research platforms and vendors actively stand in the way of access to justice initiatives, and the way their actions specifically impact incarcerated litigants and those in the criminal legal system. I also advocate for changes in the ways legal research is taught in the classroom because of access to justice issues, and focus on ethical legal research in my classroom.
