General Background:

I've been teaching legal analysis, research, and writing for twenty-five years, all of which I've spent here at Wake Forest. I have been our LAWR program director for seven years. Each year, I teach LAWR I and II, and I have taught a variety of other courses, including Appellate Advocacy, Legal Writing for Judicial Chambers, Applied Legal Concepts (an early bar preparation class), and CASE (a study skills-centered course for second-semester 1Ls who did not perform well in the first semester).

I've served the legal writing community in many capacities. I was an ALWD Board member for several years before serving as ALWD President for 2021-22. I've served on many LWI committees; currently I am on the LWI Professional Status Advice and Support Committee, which is playing a key role in helping colleagues address the potential changes that would result from the ABA voting to abandon Standard 405(d) and to expand the reach of Standard 405(c). I've spoken at almost every ALWD and LWI conference in the past 20 years, including co-leading the LWI Critiquing Workshop for the past 6 Biennial Conferences.

Areas of scholarly interest consistent with the purpose of the grant program:1

My scholarship falls primarily into the pedagogy category. For several years, I and a colleague focused on researching and writing about novice law students—their mindsets when they begin law school, their prior learning and how it shapes them as beginning law students, their experiences in early legal writing, etc. From this research we developed two articles about how to help beginning legal writers progress more effectively, with fewer struggles and fewer crises of confidence. That research led to co-authoring The Pre-Writing Handbook for Law Students, published by Carolina Academic Press (now in its second edition).

More recently, my scholarship has focused on reaching and teaching Generation Z students; my 2019 article, *Generation Z Goes to Law School*, was among the top downloads on SSRN for the many months and has generated many invitations to speaking to various groups about the topic. My *Brave Spaces* article explores how we can

create classrooms that teach Gen Z students how to navigate challenging discussions with an open mind and with respect for one another. I am currently working on an article that will help legal employers understand how they can successfully partner with Gen Z colleagues in an intergenerational work environment.

Ideas for programming Distinguished Speaker might offer a host school, including potential topics and target audiences:

The broad subjects of my scholarship—helping novice law students learn better and understanding Generation Z as law students—are relevant to anyone who has a role in educating law students, from faculty to administrators to staff. At the host schools I've visited up to this point, I've done both small-scale presentations to legal writing faculty specifically and largescale presentations designed for the wider law school community. I haven't done presentations to law students at other schools, but I would welcome that opportunity.

On a different note, over the past decade, Wake Law's legal writing faculty have moved from short-term contracts to long-term contracts to tenure-track to unitary tenure-track (for those who desire that). I would be happy to speak to any faculty and administrators about this path, especially at schools where the proposed changes to Standards 405(c) and 405(d) would necessitate going down the same path.

A few topics I am equipped to address:

- incorporating pre-writing into the legal writing classroom (this would be geared toward legal writing faculty)
- fostering the growth mindset in novice law students (this would be useful for all faculty and administrators and even for students
- teaching critical reading skills to novice law students (this too would be useful for all faculty and administrators and even for students)
- incorporating writing exercises into non-legal writing courses (this would be primarily designed to reach non-legal writing faculty)
- adapting tried and true teaching methods for a new generation of law students (this would be useful for all members of a law school community)
- Status issues pertaining to legal writing faculty

Any of these topics could be covered either in a traditional presentation format (with time for questions and discussion at the end) or in a more interactive workshop style. And any



of them could be adapted to work with law students—perhaps a pre-writing workshop or a critical reading workshop where I would lead students through some exercises designed to teach them good processes for these important skills.

In no more than 300 words, describe why a host school should consider you as a Distinguished Speaker:

My scholarship is very practical; it focuses on helping lay a strong foundation for all law students to succeed and thrive. We know anecdotally (and research bears out) that students entering law school today are not as skilled in critical reading, thinking, and writing as their predecessors. And it cannot be left solely to academic support programs or legal writing programs to address this skills deficit. It requires the commitment of all constituencies within a law school—administrators, faculty, staff, and students.

As I have researched and written about law student learning over the years, my passion for the subject has deepened, and my expertise has grown. The presentations I've done in recent years at various conferences and workshops have been very well-received; I think what I have to share is interesting and critically important, and I think I share it in an engaging and clear way.

While I think legal writing faculty could benefit from my time with them as a Distinguished Speaker, I would hope to be able to reach beyond that group so that my visit would accomplish some broader purposes. I would love to help educate non-legal writing faculty about the vitally important work that legal writing professors do. I would love to explain why it is crucial that all professors share the responsibility of teaching critical reading, thinking, and writing skills and to give them some tools to use. And I would love to be a voice of support for legal writing colleagues who are seeking improved status at their schools.
