#### General Background:

I have been teaching legal research and writing since 2005. Since 2013, in addition to teaching legal research and writing, I regularly teach trusts and estates. In 2022, I became the associate dean for academic affairs at Washburn University School of Law, a position I really enjoy because I get to mentor new legal research and writing professors! I am involved in the two national legal writing organizations, trusts and estates panels at conferences, and the Institute for Law Teaching and Learning. Prior to entering academia, I clerked for the Seventh Circuit Court of Appeals, two federal district court judges, and the Palau Supreme Court. I graduated from the University of Illinois College of Law in 2000.

#### Areas of scholarly interest consistent with the purpose of the grant program:1

My scholarly interests focus on <u>pedagogy</u> – different approaches to teaching and helping students learn, including classroom strategies, emotional intelligence, and belongingness. Since before the pandemic, I have been developing and teaching <u>online classes</u>, so I feel comfortable sharing thoughts about that process. Through the Institute for Law Teaching and Learning, I also do a lot of research and presentation work (and actual service work at my school) on <u>assessment</u>, both the institutional assessment process and individual course-level assessment choices.
