General Background:

As Director of Legal Writing, Research, and Written Advocacy at Suffolk University Law School, I have been an active leader in the legal writing field on a national, regional, and local level. I have completed several Leadership Institute trainings and have presented on leadership as well as taught several leadership classes at Suffolk as well as internationally. I have also published on the topic of leadership. I was recently selected as a Fulbright Specialist. Under my directorship, Suffolk's LPS program has been ranked in the Top 10 in the nation by U.S. News and World Report since 2013. I received the Mary S. Lawrence Award from the Legal Writing Institute (LWI) for pioneering scholarship and innovative curriculum or program design. I also received Suffolk's Catherine T. Judge Teaching and Service Award, recognizing a distinguished female faculty member who exemplifies Professor Judge's unwavering commitment to student mentorship and thoughtful pedagogy. In addition, I was the recipient of several Suffolk University Teaching and Learning Innovation Grants. I served as Chair and Secretary of the American Association of Law Schools (AALS) Section on Legal Writing, Reasoning, and Research. I was also the President of the Association of Legal Writing Directors (ALWD) and served on its Executive Committee. In addition, I served on the Board of the LWI. I was also an editor of the LWI Journal, the LWI Monograph Series, and LWI's The Second Draft. I co-founded the New England Legal Writing Regional Consortium. I have helped Suffolk host several national conferences, such as the ALWD Conference, as well as regional legal writing conferences. I served on the Executive Committee of the AALS Section on Balance and Well-being in Legal Education. I also serve on the Massachusetts Supreme Judicial Court Advisory Committee for Professionalism in Practice and Chaired the Subcommittee on Professional Identity. I have chaired numerous committees in the legal writing organizations as well as at Suffolk, including the Dean Search Committee. I also served as a consultant and coach on legal writing at law firms and government agencies. I co-authored the book, LEGAL ANALYSIS: THE FUNDAMENTAL SKILL and the book, MINDFUL LAWYERING: THE KEY TO CREATIVE PROBLEM SOLVING. I have also published numerous law review articles. In addition, I created the Legal Writing Matters blog and started a podcast called Law FaculTEAS. I have given numerous presentations across the country and internationally on my scholarship, teaching, and leadership. In addition to teaching at Suffolk, Professor Vinson I taught legal writing at Boston College Law School as a visitor. I also served as the Acting Director of the Academic Support Program at Suffolk.
